# Sustainable Management

## Importance of K-REACH Registration

### What is the K-REACH?

K-REACH (The Act on the Registration and Evaluation of Chemicals Substances) is a regulation that was officially implemented on January 1, 2015. It mandates that new chemical substances with an annual production volume of 0.1 tons or more, and existing chemical substances with an annual production volume of 1 ton or more, must be registered before they can be distributed in South Korea. The regulation also introduced a pre-registration system similar to the EU-REACH, requiring all existing substances produced at 1 ton or more per year to be pre-registered by the first half of 2019. After pre-registration, there is a grace period during which substances must be fully registered by the designated deadlines based on their tonnage in order to be legally distributed in the South Korean market.

## Why is it important?

### Purpose of K-REACH

The K-REACH law aims to protect public health and the environment by regulating the registration of chemical substances, the assessment and evaluation of the hazards and risks associated with chemicals and products containing hazardous chemicals, and the designation of hazardous substances. It also requires the collection and utilization of information on chemicals. K-REACH was introduced in response to major chemical safety incidents, such as the toxic hydrofluoric acid leak in Gumi and the humidifier disinfectant disaster, to prevent harm by proactively managing chemicals.



By registering over 150 items under K-REACH and submitting the necessary registration data, we have established a solid foundation for providing our partners with consistent and reliable supply.


